# **Ex-Officio Updates**

- Think Iowa City Monica Nieves
  - Last weekend Herky on Parade statues will be on display in the community. They will then move next week Monday and Tuesday for the Fryfest event on Friday August 30<sup>th</sup>.
- Greater Iowa City, Inc. Austin Korns
  - New 6-month Board Leadership Program application now open. This program is geared to help participants understand responsibilities and practices of serving on a non-profit board. Applications available on Greater Iowa City Inc. website.
  - Survey is out for Legislative Priorities available on Greater Iowa City Inc. website.
     This survey helps inform public policy priorities and agenda.
  - Lunch and Learn on 260e new industrial job training program has been postponed to September 10<sup>th</sup>.
- City of Iowa City Rachel Kilburg-Varley
  - During the last City Council meeting the council decided on 500 ft. separation between retailers, K-12 institutions, and higher ed buildings for Tobacco Businesses. They also decided on loss of grandfather rights after 90 days of use ceasing or 60 days after permit being loss.
  - Council decided to drop the parking rate for core downtown on street parking to \$2.25 down from \$3.
  - Dubuque St. should be fully reopened in the coming weeks. Gilbert St. should be opened by winter.

On the expense side the notables are; marketing cost for Dubuque St. construction project, IDA registration for Betsy, and the first Block-by-Block invoice. Budget vs Actual reflects a year balance -\$289,623.61 for net income that is incorrect and actual year end net income for FY24 was \$44,700.

support would be best in the stages after the RFP has been awarded. ICDD will receive
\$250,000 of ARPA grant funding for lighting in alley ways by the Graduate Hotel and
Midwest One.
